**Installment Payment Contract –Fall 2008
FOR RESIDENT STUDENTS ONLY**

DO NOT use installment option if you have approved financial aid.

I would like to request participation in the State University Fee Installment Program for **Fall Term, 2008**. Under this program, I will be able to defer 50% of the State University Fee for 30 days from date of the approved contract. I agree to pay the initial payment consisting of the first 50% of the State University Fee, all of the miscellaneous campus registration fees (Facilities, ID, ASI, SU, IRA, and SH), as well as the **\$22.00 non-refundable service charge**. The contract must be approved and the initial payment received **by September 11, 2008**.

If the balance has not been paid **by the due date**, I realize that I will be responsible for a **late charge of \$20.00**, that I may be de-registered for the academic term and may receive no credit for my classes, that I will not receive a refund for the fees paid for the term, and that this will preclude the option for an installment plan in subsequent quarters. The University will be entitled to withhold any of its services from me and take any other legal remedy available, including submitting my account to a collection agency or credit bureaus; offsetting funds owed against amounts due me from the State of California; and/or pursuing legal action. I agree to pay all costs of collection, including attorney fees and court costs.
