What is WSCUC?

The Western Senior College and University Commission (WSCUC), formerly known as “WASC,” is the accrediting agency that aids institutions in developing and sustaining effective educational programs, while assuring the community that the accredited institution has met the high standards of quality and effectiveness.

What was accomplished in the Spring 2018?

- ✓ General Education, IRPA Assessment and Academic Programs websites were restructured
- ✓ Over 45 students, faculty, and staff from the main campus and AV have collected over 550 documents for the Institutional Report
- ✓ 8 Writing Teams have been working to create the first draft of the Institutional Report
- ✓ Two Campus Open Forums have been scheduled with the comments collected and returned to campus

What will be accomplished in the Summer 2018?

- CSUB Self-Evaluation (Lines of Inquiry) to be provided to Cabinet
- CSUB Institutional Report Editor (Dr. Marit MacArthur) will harmonize the different sections of the Institutional Report
- WSCUC CSUB Steering Committee will help refine the first draft

When will the Institutional Report be made available?

The first draft of the Institutional Report will be made available to campus in August of this year. The Academic Senate will begin its review in September and Cabinet will then review the report before the end of the semester.
