## Requirements

In order for the Office of Financial Aid & Scholarships (OFA&S) to determine your eligibility for summer financial aid, you must:

- Submit the 2009-2010 FAFSA to the Department of Education
- Submit a completed 2009-10 Summer Financial Aid Application to the OFA&S
- Submit a completed 2009-10 Charge Authorization/Fee Certification Form to the OFA&S
- Be enrolled in at least half-time units in financial aid eligible summer courses  
*(6 or more units for undergraduate and credential students, and 4 or more units for graduate students. Please be aware that Open University courses will not count towards financial aid eligibility, however, certain regional programs and extended education courses may be eligible.)*
- Submit all other documents displayed on your 'To-Do List' on [my.csub.edu](http://my.csub.edu)

If your FAFSA data is selected for the Verification Process, you will be required to submit additional documents to the OFA&S before your financial aid eligibility and award package can be determined. Please visit [my.csub.edu](http://my.csub.edu) to view your financial aid status and review/download any required documents listed on your 'To-Do List'. Once you submit these documents, and they are reviewed and verified, your awards will be finalized. *Please note that all students will be required to submit the 2009/2010 Charge Authorization form.*

Financial aid will be initially packaged based on full-time enrollment, which is 12 or more units for undergraduate and credential students, and 8 or more units for graduate students, but your award will be prorated automatically based on your actual enrollment up to Census Day each term.

You must visit [my.csub.edu](http://my.csub.edu) to accept or decline any loans awarded to you. If you are accepting loans at CSUB for the first time, you will need to complete the Loan Entrance Counseling Session and the Master Promissory Note. Please visit those links on your 'To-Do List' to complete.

Summer quarter classes begin June 23, 2009; however, financial aid will not be disbursed into any CSUB student accounts until **after July 1, 2009**. For refund dates, please check our web page. Book vouchers will be available upon request beginning the first day of classes.
