# Webinar for Advisors & Counselors October 14, 2021 3:30-5:00 p.m.

Presenters: Nora Leyva and Theresa Luu – San Diego State University

**Topic: Retention and Graduation Initiatives** 

California State University (CSU) advisers have been charged with leading Graduation Initiative 2025 (GI 2025) efforts but how can they rise to the challenge using their limited existing resources? This presentation will demonstrate how a multidisciplinary college at a CSU campus developed strategic and multi-level student success initiatives led by advisers to increase graduation rates and meet its GI 2025 goals. These initiatives include rolling out a mandatory advising program, creating effective peer advising teams, and supporting students at-risk or on probation. The presenters will guide attendees through the process of developing and implementing said initiatives and address challenges related to large student to adviser ratios, communication planning, technology, and more.

The presenters serve as Academic Adviser and Student Success Specialist in the College of Professional Studies and Fine Arts, which houses 7 schools and 3 departments. As of Fall 2019, the college has approximately 4,700 enrolled students: 700 students identify as First generation, about 33% are URM, and about 25% are Pell Grant recipients. In addition, every incoming freshman student is admitted as pre-major with the intent of being declared into the major by completing the preparation for the major by the end of their sophomore year. While the University is on track to meet its GI 2025 goals, each College has developed its own strategic plan to ensure each department reaches the goals across various student subgroups.

The School of Public Affairs currently has the largest student enrollment, including over 800 students in the Criminal Justice major. As of Fall 2019, about 63% are female, 60% identified as URM, and 45% are Pell Grant recipients. Through mandatory advising, the College of Professional Studies and Fine Arts has created opportunities for students to meet with their major adviser at critical milestones to ensure they are successfully moving through the pathway from pre-major to major and graduate in four years.

**SUBJECT:** Uniformity of Advising Notes -- A Referral to the Provost's Council

CSUB has adopted RunnerConnect (RC) to improve the coordination of academic advising on our campus. Among its many functions, this EAB technology allows for notetaking of student academic advising meetings. Professional advisors and many staff have been trained to use it, with faculty next in line. Dr. Jaimi Paschal heads the training and is our contact person with EAB (her training schedule is attached).

Dr. Paschal has prepared a training documentation, located on the csub.edu/RunnerConnect website. In addition to what is already posted, Dr. Paschal created guidelines on writing advising notes, using feedback from the RunnerConnect Campus Leadership Team, to meet standardization, ethics, and utility to student's academic progress (see attached).

For students to experience a seamless navigation in their academic journey, it is important that careful advising notes accompany each student's record, especially if they change majors, or need to see different advisors. RC uses standardized, systematic statistics to inform decisions regarding advising accomplishments and needs. Note taking adds qualitative meaning to academic advising processes. If resources can be allocated to create templates of standardized notes, creating quantification outcomes, these will further enrich RC analytic functions.

The value of RC notetaking can be seen when students see professional advisors as freshmen/sophomores but see faculty advisors as juniors and seniors. Note taking is also useful when athletes are placed in a common major to meet athletic eligibility. As they advance in their studies, a careful tracing of academic advising is needed for them to stay in scheduled time to degree. Unscheduled appointments also benefit from advising note taking.

Thus, the Advising Leadership- and RunnerConnect Campus Leadership- Teams recommend that the Provost's Council endorse, promote, and provide resources for the use of RC's advising notes as a best practice of the Graduate Initiative 2025 and student success. Strong administrative support through implementation, publicity, and finances help create enduring lessons learned and best practices of high-quality academic advising. Campus buy-in is crucial.
