Cal Govt Require and AP Exam

- V. Lakhani, the president just signed the memo today providing a waiver to all 106 students that have been here with that AP test score, those students will not be penalized when they are up for graduation.
- ➤ V Lakhani Mark Martinez is coming up with a one-unit course that will help the fall 19 students and on coming in with that same AP score they will need to take that one-unit class, or he is also working on a test for these students.
- > V. Lakhani will send the memo to the Student Success Network, the Associate Deans will pass it to the chairs, they will pass it to the professional advisors.
- This will show on the student's Academic Requirement page.

Course Substitutions

- ➤ V. Lakhani All substitution waivers are going to be electronic. At the moment the advisor request module does not support attachments. At Fresno State they have a mod that allows attachments, Tommy H. contacted IT department and obtained a mod. The module will be tested, once everyone is comfortable with it we will hold one more meeting to formalize that process and this will be passed to Diane Wiggins.
- > Dianne W. has access to post substitutions and waivers (she did not have it before).
- > This will be a workflow, parameters will need to be set once we come to the final part. Each department will need to figure out who will have access in each department.

Add/Drop/Withdrawal Form

- ➤ J. McCune gave a review of the form. This form was sent to DCLC for approval, a couple of chairs requested to have Dept Chair signature on the form, so they can check that pre-requisites are being met.
- ▶ BPA has an internal process, they use a stamp that the advisors use to show if a student is eligible for the courses.

- > T. Boone-Holladay recommended for Jennifer to contact Doreen Anderson-Facile and explain the situation with this form. It would be better to have this signature after census day and let her know numbers of how many will have to be done in a timely manner.
- > D. Freeman asks if this form catches holds?

- > J. McCune would like to have at least one training session this semester.
- L. Gubkin, suggests Generation Z training should also be open to faculty since they also advise.
- L. Zuzarte will check with Christa Clark and Denise Tucker to see if they can have training on the Articulation Website sometime in February. This would be for all professional advisors, All faculty and staff.
