Community College Pathways - Yvette Morones

- There is a concern with workload issue for the department chairs for the updating of the pathways, and not having faulty or staff representation on the committee.
- Bakersfield College already has a website built for these pathways.
- Pathways are stored in the CSUB transfer center, we are currently building a website for the pathways.
- Natasha Harris is in communication with all the chairs, so they can get updates and they are going to have more convenience just to discuss these updates.
- Member wants to know the rationale for having Pathways program in addition to the ADT.
 - When a student gets here we can only have them take 60 units. When a student gets here it is determined what courses they can take to fit into those 60 units, regardless of what they are taking at BC, this gives a student a clear path as to what to take first two years at BC and next two years at CSUB. This is done to improve their two-year graduation at CSUB.
- V. Lakhani will speak to the chairs and clear up their concerns, he requests the chairs contact him directly to get a clearer picture of what they need.
