E. New Protocol Reviews

- Protocol 03-51:** "Evangelical Christian Pastors and Dishonestly Within the Leader-Subordinate Relationship with Rhonda Dugan and Brandon Bentle [Sociology]. Primary readers are Newberry, Herndon, and Duran.

Following introductions, the PI summarized in some detail. The church has been important in his life and he has lots of personal experiences with pastors. He is aware of pastors who have experienced dishonesty and have had to figure out how to deal with it. He wondered how common this is. It is an interesting topic, given the supposed firm ethical foundations of religious organizations. Theoretical background involves conflicting ethical principles associated with different roles in the organization and "organizational scripts". Questions followed.

[Q = question, A = answer, C = comment]

Q: You haven't found any studies of dishonesty among church personnel? **A:** No.

Q: You will be interviewing pastors from outside the Bakersfield area? You won't show up in their congregation? **A:** Interviews will be mainly in the San Joaquin Valley section of a very large evangelical church.

Q: If I were a participant, I'm wondering if I would be honest or worry a great deal about my comments getting back to others involved in the church. **A:** That may be a limitation. However since the participants are volunteers, perhaps fewer dishonest people will be involved.

Q: If the senior pastor knows who chooses to participate, does this place the participants at risk? So, how easy will it be to identify the participants? **A:** There is a pool of over 400 potential participants from which 10 senior and 10 associate pastors will be chosen.

C: Being allowed to stop doesn't reduce the risk of a pastor being identified by his congregants.

Q: Some of the questions seem quite threatening and raise issues about being a whistle blower. **A:** One thing that should lessen that particular concern is that many of these pastors will have had many years of experience and will be talking about dishonesty that they had experienced years in the past, so it wouldn't be about current events.

Q: Best to communicate clearly in the consent form that names are not wanted. **A:** Will do.

When there were no more questions, the student researcher and faculty mentor were invited to leave and the Board deliberated in Executive Session. Following discussion, the following conditions were agreed upon:

1. Add to the consent form a statement directly discouraging use of names.
2. Add to the consent form that specific events described in results will be disguised to prevent linking them to specific persons by inference.
3. In presenting the findings prevent readers from inferring the identification of the particular denomination involved by not reporting the number of pastors in the overall pool and their geographic location.
4. State in the consent form with whom in the church the results will be shared.
5. Add language to the consent form discouraging discussion of abuse and related reportable offenses and indicate what actions would be taken if such activities came to light in the interview.
6. In communications with participants and reporting of results, be less specific about the nature of the subject pool from which participants are drawn.
7. The IRB only authorizes the addition of relevant "impromptu questions".

Duran moved, Butler seconded, 9-0.

The investigators returned and were so informed.

F. Renewal of Authorized Protocols

1. **Renewal of Protocol 03-03:** "Establishment of a Participant Pool for the Department of Psychology" with Carol Raupp. Primary readers are all members.

One more study has been approved for subject pool use since the renewal request was submitted. Also updating the renewal document, the psychology chair has received no complaints, nor have the instructors teaching Psyc 100. Questions followed.

[Q = question, A = answer, C = comment]

Q: How do students register complaints? **A:** Instructions are posted on the bulletin board near the sign-up sheets. These instructions provide the contact information for the psychology chair and for Raupp. The complaint filing info is also included in the consent forms of studies using the subject pool.

There was a motion to renew the authorization of Protocol 03-03, Duran moved, Lee seconded, 9-0.

There was also a discussion of a separate protocol in which a former CSUB student, who is no longer affiliated with CSUB, but is sponsored by Duran, proposes to recruit participants from the subject pool for a student of attitudes about gay and atheist persons as parents. It was decided that the Board does not wish to prohibit this as long as there is a CSUB faculty mentor or sponsor involved, and the protocol has been approved by our IRB.

G. Continuing Review of Authorized Protocols

1. Protocol 07-91. Quarterly Report with J. J. Wang. Primary readers are all members.

Funding is now on a 5-year cycle, but this has required an amendment to bridge from the 3-year cycle which has involved serious work. Wang noted that CSUB students are working at some of the agencies.

There were no questions, but a board member noted that The Ready-to-Start program appears to be getting great results with minimal investment. Wang was thanked for his efforts.

There was a motion to accept the quarterly report for Protocol 07-91, Gilchrist moved, McCleary seconded, 8-0.

2. Edvention and Related. With Sarah Brooks. Primary readers are all members.

Protocol 10-157: "Baseline Preparation Data Survey for Edvention Fellows"

Protocol 11-66: "Cycle of Activity Model [CAM] Participant Survey"

Protocol 11-68: "Discussion Responses Regarding iPad Use Among a Select Group of Pre-Service Teachers"

Protocol 11-117: "Edvention Partners – Effects of CSU Teacher Preparation on K-12 Student Achievement"

Following introductions, Brooks summarized. Brooks is standing in for Schultz, who is out of town on Edvention-related activities. Brooks proceeded protocol by protocol.

Protocol 10-157 [Edvention Fellows]. The 2012-2013 cohort is underway and a focus group has been added to the protocol. The training has been expanded to all of the students, so that 150 are now involved, as approved to the 15 in each yearly cohort. They will submit a new protocol for data collection in the expanded project.

[Q = question, A = answer, C = comment]

Q: The new protocol will replace the original 10-157 on the Edvention Fellows. **A:** Yes. We plan to collect additional data.

Q: Who de-identifies the student data that you get? **A:** It's the CSUB staff person who normally has access to those data.

Q: So, the broadened group is not included in the 10-157 activities? **A:** Correct.

Q: 10-157 will continue? **A:** Only until next fall, when those students will have graduated.

Protocol 11-66. CAM. This involves applying the 15 reform elements and bringing together the K-12 and higher education institutions. They have already used some of the data collected under this protocol in a federal grant proposal.

Protocol 11-68 [Using iPads]. This continues.

Protocol 11-117 [Student Achievement]. Struggles continue to obtain student performance data to enable a comparison of students taught by Edvention Fellows as compared to control students. This is the outcome assessment that is critical to evaluate the program positively, so it is frustrating that the data are coming in so slowly.

Brooks was invited to leave and the Board deliberated in Executive Session.

There was a motion to accept the quarterly report, Lee moved, Gamboa seconded, 8-0.

Brooks returned and was so informed.
