This will assist Sumaya in reviewing protocols in a timely manner. Sumaya requested that Wilson become an alternate so that she can solely focus on the review of Exempt and Expedited protocols. **Inclusionary statement regarding selection of participations in Cayuse IRB Initial Protocol.**

## **NEW BUSINESS**

### **Full Board Review Protocols [5]:**

**Protocol 21-178** (Principal Investigator: Soeun Park) *Emerging Adult Immigrants' Activism at Home*. Primary Reviewer: Nate Olson, Secondary Reviewer: John Stark

After introductions, the PI provided an overview of the project. After a discussion and questions of clarification addressed to the PI, the following was determined by the board to be missing from the protocol.

#### **Findings: The PI was requested to address the following issues:**

1. Make clear that participants must speak English in order to participate.
2. Add to the protocol and information to the participants the importance of where they choose to do the Zoom interviews to allow for privacy.
3. Provide the participants the Guideline used for virtual psychotherapy and attach the guide in the protocol in Cayuse (can add in the section for additional information).
4. More fully discuss the emotional risks of participating and the resources provided to deal with these risks. Add phone numbers in the protocol and the consent form.
5. Make clear that the study does not ask for or is interested in citizenship status.

3. PI was asked to limit Mechanical Turk recruitment to US participants only and to make sure to add this information to the inclusion question in Cayuse.
