The National HEP/CAMP Association is a nonprofit membership organization comprised of over 100 High School Equivalency Programs (HEP) and College Assistance Migrant Programs (CAMP) situated in IHEs (Institutes of Higher Education) throughout the United States and Puerto Rico. The National HEP/CAMP Association's priorities are to increase the educational opportunities to the family members of migrant and seasonal agricultural workers. The Association's membership provides dropout recovery and placement in postsecondary education or employment to over 7,000 participants each year through the HEP programs. CAMP provides economic and financial support and other non-financial support services to first year college freshmen, most of whom are the first in their families to seek a college degree. The Association provides scholarships and sponsors summer

internships for college students from farmworker families. The Association also provides professional development for its members, ensuring the effectiveness of HEPs and CAMPs.

According to 2019-2020 CAMP data presented by the U.S. Office of Migrant Education (OME)\*:

- **83.8% of all CAMP** participants successfully completed their first year at an IHE (24 credits earned and in good academic standing).
- 95.6% of all students that successfully completed CAMP (24 credits earned and in good academic standing) were enrolled in an IHE the following year.

According to 2019-2020 HEP data presented by the U.S. Office of Migrant Education (OME) \*:

- **60.5% of HEP students** who completed their course of study earned a high school equivalency diploma (HSED) or its equivalent.
- 75.5% of HEP students that earned their GED or its equivalent enrolled in an Institution of Higher Education (IHE), improved their job status or enrolled in the military.

#### PROGRAM OVERVIEW

Cambridge Academies' Enterprise Migrant Project serves farm-working families at multiple rural sites in two of California's Central Valley Counties: San Joaquin and Stanislaus. These counties have very limited transportation linking these outlying rural areas with larger cities so a great percentage of farm workers live in isolated pockets throughout both counties. The COVID-19 pandemic gave us an opportunity to pivot our program toward a hybrid online and site-based approach which has helped families not only receive high school education services but also has served as a way for students to learn how to use modern technology tools resulting in expanded employment opportunities. Currently all of our classes, except for onboarding sessions and social events, are conducted online.

The Zoom environment is our virtual classroom that students quickly embrace. Participants are helped with funding for Internet connectivity and with the procurement of Chrome Books. Staff delivers study packets to their homes when students can not attend the on-site overview classes and coaches them one-on-one until they learned to download and upload their work. Their computer skills have gone from 0 to 100 very fast, which has allowed them to upgrade employment and participate in college online ESL classes.

**Results:** Our **students**: 1. LOVE the online environment, especially being able to participate in their Zoom scheduled classes and also reviewing the material by signing on to observe classes held at different times; 2. Developed technology skills which will help them in their next steps; 3. Like learning at home while watching their kids; and 4. 100% of our graduates ned up for ESL online classes as soon as they passed their last GED exam.

#### PROGRAM COLLABORATIONS

Partnerships and collaborations are vital to the Enterprise Migrant Project. We are grateful for the support given by regional Internet providers by offering discounted rates and for local businesses that have so graciously allowed some of our students to use their internet access to participate in classes when internet service at their homes was not available. We are also thankful for employers such as Amazon, that support our graduates by giving them training and an opportunity to join their company as well as grateful for agricultural employers who value our students' efforts and upgrade their employment status.



# **CENTRAL VALLEY OPPORTUNITY CENTER** High School Equivalency Program

# **HEP PROGRAM OVERVIEW**

Federal funds from the U.S. Department of Education, Office of Migrant Education were given to Central Valley Opportunity Center to promote High School Equivalency Program (HEP) to the community. The goal is to provide migrants, seasonal farmworkers and their family members with a unique and exciting opportunity to obtain a high school equivalency certificate. HEP is a 16-week GED program offered in English and Spanish. The participants will receive individualized instruction within a structured GED curriculum as well as career, academic, life skills and personal counseling. The program also assists participants with their individualized educational/employment goals such as entering a postsecondary

education, military service, or to be placed in a career development program. The program is offered in California within the counties of Merced, Modesto, and Madera.

#### **PROGRAM OVERVIEW**

Operating since 2010, the High School Equivalency Program (HEP) at **California State University, Bakersfield (CSUB)** is one of fifty HEP Programs federally funded through a competitive grant process by the U.S. Department of Education, Office of Migrant Education.

HEP is an educational equity program designed to assist seasonal agricultural workers and members of their immediate family to complete their high school equivalency and, subsequently, obtain improved employment, begin post-secondary studies or enroll in a vocational training program.

**Bakersfield-HEP** is one of 13 HEP Programs in the State of California and the only project providing these specialized services in the Southern San Joaquin Valley. **Bakersfield–HEP** is on its third funding cycle through 2025. In addition, **Bakersfield–HEP** has exceeded or met the national performance targets for most fiscal years.

#### **BAKERSFIELD-HEP STUDENT HIGHLIGHTS**

HEP Graduates have earned four-year degrees from CSU Bakersfield.
HEP Graduates are currently enrolled at Taft and Bakersfield College.
HEP Graduates are currently enrolled in NO-FEE trainings such as: Barber School, Welding, Auto/Diesel Mechanic, and Bookkeeping.
HEP Graduates are currently working in salaried, full-time, nonagricultural jobs with medical benefits, and increased pay.

The Sacramento State High School Equivalency Program (HEP) is one of the fifty federal funded programs nationwide designed to assist migrant or seasonal agricultural workers 18 years of age or older currently not enrolled in school obtain the equivalent of a high school diploma. HEP also helps students prepare to move on to higher levels of education or training and into more stable and better paid form of employment.

#### **Program Highlights**

- Provide access to high school equivalency (HSE) completion to out of school migrant and seasonal farmworker youth and their family.
- Assist high school equivalency (HSE) completes move on to higher levels of educations, training and/or into more stable and better paid employment.

#### **PROGRAM OVERVIEW**

The Mendocino College HEP Program is made possible by a US Department of Education - Migrant Education Office. Mendocino College HEP serves Mendocino and Lake Counties which are in rural areas in Northern California.

The High School Equivalency Program (HEP) helps migratory and seasonal farmworkers (and their immediate family members) to obtain the equivalent of a high school diploma and, subsequently, to gain improved employment, begin postsecondary education or training.

Mendocino College HEP was refunded in 2020 and this program is in year three of this new cycle.

#### Mendocino College HEP SERVICES

Project activities employed to achieve the measurable objectives includes outreach and recruitment, orientation, counseling, diagnostic screening and assessment, academic instruction, books and curricular materials, geographically balanced instructional locations, student services (financial aid, etc.), academic workshops, tutoring program, testing fees, childcare, transportation, field trips, health and vision care, enrollment, career and job placement support.



# High School Equivalency Program



West Hills Community College District (WHCCD) has a rich history of serving the educational needs of the west side of the San Joaquin Valley for 89 years. The district serves nearly 10,000 students annually and covers 3,464 square miles with colleges in Lemoore and Coalinga and an education center in Firebaugh. The WHCCD High School Equivalency Program (HEP) is a five-year grant operating from 2021 – 2025. The program is funded to serve 85 commuter students from migrant or seasonal farm worker background annually with a budget of \$464,000.

WHCCD HEP is committed to assisting the completion of High School Equivalency (HSE) through academic and support services that address students' educational, career, personal, health, and financial needs. HEP provides placement services in universities, colleges, vocational institutions, military services, and other postsecondary activities or career advancement.

Additionally, WHCCD offers financial assistance, career readiness workshops, and cultural and educational leadership activities. The goal of the program is to empower students with the necessary academic/life skills to complete their HSE and exceed Obj. 1 and 2 National Targets: GPRA1 and GPRA2 performance requirements.

#### ENTERPRISE MIGRANT HEP PROGRAM Success Story

#### Jenny Gutierrez



Jenny Gutiérrez is a 33-year-old mother of two young children and a HEP graduate currently working at Amazon and living in Santa Nella, California. Her father came to this country from Tabasco, Mexico to work in agriculture and provide a better future for his family. For 15 years, Jenny had worked multiple agricultural jobs in and around the Central Valley, but was not able to progress without a high school equivalency certificate (HSE).

In 2018, Jenny started and quit the HEP program after taking her first exam without even finding out her score. She remembers feeling frustrated and disappointed because she lacked enough personal time for school and confidence to complete the high school program. In the summer of 2021, her sister Sehydi, completed her high school equivalency in our HEP program and was able to quit working in the fields and get a better job. Her sister's accomplishments motivated Jenny to return to our program for a second time in the Fall of 2022. This time, our online Zoom classes allowed her to learn from home at a time that aligned with her work schedule and her children's school times. When she was not able to sign on to class, she learned the material through our assigned YouTube videos, online resources, and homework.

While taking HSE classes, she developed the courage to apply for a job at Amazon and to her surprise, she was hired! Her new job required her to maintain a demanding 10-hour night shift assignment, to commute two hours a day, and still care for her family and study for her HEP classes. In spite of these challenges, Jenny completed her entire high school equivalency certificate program in the span of four months!

After attaining her HSE, Jenny enrolled in an employee program at Amazon where she is currently attending classes to get a commercial Class A driver's license. She looks forward to receiving higher pay and family benefits and hopes that one day she can attend college to become a nurse.

Jenny is a strong female role model who has demonstrated invincible perseverance, and an admirable capacity to raise a family, advance in her education goals, improve her job prospects and achieve the American dream that her parents had sought and worked hard for when moving to this country.

We are proud of Jenny and of many others in our HEP program whose lives have been transformed by pursuing educational goals and a better future for their families.

### Vivian Mejia-Cardenas

Since 1988, my mom has been working in the fields of Stockton. CA and continued to migrate from Mexico to the US on a yearly basis. I remember when I was 4 years old, I didn't understand the sacrifices my mom was making by leaving us for about six to eight months, she would migrate to the US and return to Mexico. In 2018, my father joined my



mother in coming to California to work in agriculture. They have experienced seasons that defeat them with long working hours. Even though farm working was challenging, they wanted to give my family a better life and more opportunities. They both work packing cherries, apples, pears, and other fruits. They find pride in being farm workers and know that it is a job that many are not able to do but as they aged it is becoming more difficult.

In 2019, I joined my parents in Stockton, CA and later, with the help and encouragement of my parents, found a program to help me get my high school equivalency. After a few weeks of searching for a program, we found the Sacramento State, High School Equivalency Program. Because of my parents' farm working background, we all qualified for the program and signed up. By June, my mother, father and I all graduated, and it was one of my proudest memories. However, later that year my mother was diagnosed with stage IV lymphoma, bringing her priorities to her health instead of her education. My dad had to work more to provide for our family and my mom could focus on getting better.

My parents' encouragement of getting an education was like planting a seed that would grow immensely within me. I've been doing my best in school because I enjoy it and I felt like I owe it to them to work hard as they do in the fields. Financially, my family is struggling, and community college is the best option for me. Last fall, I enrolled at San Joaquin Delta College with the goal of transferring to a four-year university. Going to community college gives me the opportunity to save money especially now that my mom is not working. Both semesters, I enrolled in the maximum units allowed for a pre-medical major.

In the beginning, I wasn't convinced about pursuing a degree in the medical field, mainly because it is expensive and time consuming. However, I was reminded of my hard-working parents and my mom's health issues; that inspire me to continue in the health field. It won't be a smooth journey, but with determination, effort, and support from this scholarship, it can be possible. I know I belong on the graduation stage of the four-year university of my dreams. On that day, I hope to look out into the crowd to see my parents cheer me on as they call my name, Vivian Mejia-Cardenas.

## Achieving the Dream

Hartnell Community College, High School Equivalency

Gabriela Zavala Gaytán has now lived in the United States for over 16 years. Gabriela immigrated to help her parents have a better life in Mexico and so that they could finally have a house of their own. Gabriela had always had the dream to attend a university; however, upon moving to California, that goal seemed impossible. Gabriela found it difficult to move to a different county where she did not know anyone to help her navigate her new home. She also found it challenging to communicate with others since she did not speak English. She tried to learn as much English as she could at work and



whenever possible attended a community center to learn more. By 2018, she learned that she could enroll in college classes without the need of a social security number. She enrolled in classes, but had to drop out due to work and having to take care of her daughters. Her husband and her had a difficult time making ends meet. However, in 2021, she lost her job and her mother encouraged her to go back to school, and Gabriela decided to give school another try. 2022 was an excellent year for Gabriela. She found the Hartnell College HEP Program and she was able to earn her High School Equivalency in only four weeks. She continued her credit classes at Hartnell College, and was able to earn a certificate in Business Information Worker Level 1. That same year she was able to obtain a job permit. On August 16, on her mother's birthday, Gabriela made her promise that she (Gabriela) would continue studying to get a degree that would represent all the effort to thank her for all the efforts her mother made to giver her values to achieve her goals. However, Gabriela's mother passed away on December 31, 2022 and would not be able to see Gabriela on the stand and receive that long-awaited diploma. Gabriela says, "I know that from heaven she will be happy with my achievements and she will continue to bless all the people who have helped me achieve it. Because she always told me that God puts angels disguised as people to help us achieve our dreams and goals. So, I have to achieve my mother's dream of seeing me walk on the stage and receive that diploma."

#### **Delia Ramírez**

Delia Ramírez graduated from the Mendocino College HEP Program in 2018. She enrolled in Mendocino College classes after she graduated from the HEP program. She lives in Fort Bragg, CA, a rural area on the Mendocino County Coast with limited resources and opportunities for students like Delia. Mrs. Ramirez got a job opportunity to work as a bilingual assistant at the Fort Bragg Unified School District in 2018. The COVID pandemic hit and she was transferred to the FBUSD Food Service Department, where she is responsible for receiving the products and delivering food to the different schools in the district.

"The Mendocino College HEP Program not only helped me get my High School Equivalency Certificate, but it also opened doors for me to continue taking college classes and then receive my Associate Degree in Liberal Arts and Science with an emphasis in Education. My next step is transferring to Sonoma State University and getting my teaching credential. I never imagined attaining all these goals. At that time, her goal was to get a Pharmacy Technician Certificate, however, her study plan was tragically interrupted 8 years ago when a terrible accident killed her husband. She was 5 weeks pregnant at the time.

When her child was one year old, she connected with a community partner, Via Esperanza Family Resource Center, where she received parent education courses, child development classes, and motivational support. Angelica began taking GED prep and English conversation classes, but could not continue due to lack of financial resources and inability to pay for her exams, her goal once again came to a halt. informed me that the HSE will help me in many ways, not only to get a better job but also with my immigration legalization process. I received my visa and looking forward to starting my new career. These educational opportunities will assist me in getting a better job for my family, who supported me through my education journey.





## **High School Equivalency Program (HEP)**



I want to talk about a program that changed my life. Its name is HEP at CVOC. This program made an immense change because it made my dream come true, from attending college on to transferring to a university and then being able to graduate. That dream would not have been possible without Ms. Bobadilla's help. She was the one who saw potential in me and my dream of being able to continue with my studies. In Mexico, I did not finish elementary school because of financial situations. I had no education to begin with when I made the commitment to attain my GED in the program. Thus, it was not easy; I had to start from zero.

It was difficult and almost impossible, but thanks to the experience and skills my teacher had, mainly the love she has for what she

does, it was easier than I thought. She gave me the idea of studying psychology because she liked my skills at helping people analyze their lives and listen to their problems. Therefore, HEP at CVOC is not just a program; it is my present and my future in every aspect because it did not only make my dream of becoming a psychologist come true. CVOC also gave me the opportunity to get my Class "A" driver's license, so I could work to better my family and myself.

### **Dora Olivares - Madera HEP 16 Student**

I was born on May 24, 1967. In a small community called "El Pueblito". Being the youngest members of the Hernandez Larrondo family; dad John, mom Lupita, and eight siblings, six women and two men. I attended elementary school right there in "El Pueblito". My school was called "Niños Héroes". I was a member of the honor escort on Mondays and public holidays. Like September 16th, Independence Day; November 20th, the day of the Battle of Puebla; February 24th, Flag Day; and other holidays. When I finished elementary school, I was enrolled in middle school, which was far from where I lived. However, that didn't stop me from attending. It was the most beautiful three years of my early youth.



During middle school, I had the privilege of being a member of the honor escort of the municipal presidency, in which we led the civic events and the municipal parades. Later, I continued to high school, which was even more withdrawn but still created no

obstacle for my attendance. Since it was remotely far, I had to walk for about an hour and forty minutes.

In my 20s, I came to the United States of America, a fact that changed my life. My first obstacle was arriving in a country that does not speak the same language as mine. Followed by culture, traditions, and the struggle to survive as an immigrant. I worked as a salesperson house-to-house, in the flea market as a fruit seller, and in agriculture. Agriculture was the biggest activity I worked on as an immigrant. Then a company that was just starting hired me. This happened in 1996; I worked there for almost 24 years as a supervisor. In 1997, my only son was born. He was my greatest motivation to continue the daily struggle. In February 2021, I had surgery on my left shoulder. A fact that changed my life.

Now I find myself in this institution called CVOC, trying to achieve my dreams like most migrants. We wish for an opportunity to progress. I completed cooking training in July 2022 and obtained my high school equivalency certificate in January 2023. Currently, I am employed at CVOC as a cook—the start of a better life.

### **Maria Hernandez - Winton HEP21 Student**

Children of agricultural workers face tremendous obstacles in completing high school and pursuing higher education. These students move frequently and these frequent disruptions contribute to a high rate of drop-outs and a low rate of college attendance. For nearly 50 years, the **High School Equivalency Program (HEP)** and the **College Assistance Migrant Program (CAMP)** have enabled children of agricultural workers to pursue higher levels of education and secure jobs that allow them to become successful and contributing members of American society.

**HEP** helps students obtain a High School Equivalency Diploma/Credential (HSED) and, subsequently, begin postsecondary education, enter military service, or obtain employment. HEP grantees provide intensive instruction and support to students who have not completed high school. **CAMP** assists students in successfully completing their first academic year of college and continuing at a postsecondary education institution. CAMP grantees provide academic support, stipends, and other support services necessary to ensure that students succeed in college.

The HEP/CAMP programs are authorized under section 418(A) of the *Higher Education Act* and administered by the United States Department of Education's Office of Migrant Education (OME). Currently, there are over 100 HEP/CAMP projects throughout the country. The U.S. Department of Education awards *competitive* five-year grants to Institutions of Higher Education (IHEs) or private non-profit organizations that work in cooperation with IHEs. Congress recognized the importance of HEP/CAMP programs when it increased the program's authorization level to \$75 million in the *Higher Education Opportunity Act of 2008 (HEOA)*.

- HEP/CAMP PROGRAMS ARE PROVEN EFFECTIVE AND ACCOUNTABLE: The High School Equivalency (HSE) passage rates for HEP students are substantially higher than those of other HSE preparation programs, and retention rates for first year students served by the CAMP program are significantly higher than those of most IHEs. During the 2016-2017 project year, 67.5% of HEP students who completed their course of study earned a HSE or its equivalent. In 2016-2017, 88.2% of all CAMP participants successfully completed their first year at an IHE (24 credits and in good academic standing) and 96.6% continued on to their second year in college.
- <u>HEP/CAMP PROGRAMS ARE UNIQUE AND NOT DUPLICATIVE</u>: HEP/CAMP programs are the *only* federal programs that help the children of agricultural workers a unique population of students that face tremendous obstacles obtain their HSED and pursue higher education.
- <u>DEMAND FOR HEP/CAMP PROGRAMS</u>: In grant competitions, the U.S. Department of Education received many more HEP/CAMP grant applications from across the country than available funding. For example, during a recent competition, CAMP received 33 applications and 18 projects were funded and 16 were not. HEP received 29 applications and 16 were funded and 13 were not funded.
- <u>GOOD FOR THE ECONOMY AND RURAL COMMUNITIES</u>: HEP/CAMP projects help students get better jobs and therefore contribute more to the tax base in their community. The HEP/CAMP grant awards to IHEs and non-profit organizations bring jobs and spur economic activity in the local communities where grants are awarded, especially in rural areas where many of these programs are located.
