Important Reminders:

Apply early! USCIS allows you to apply up to 90 days prior to your graduation date and up to 60 days after your graduation date, provided that it is received within 30 days of your immigration advisor issuing a new I-20 recommending OPT. Your application will not be considered by USCIS if received after 60 days from your

graduation date. Only apply for OPT if you have filed your grad check, met all the graduation requirements listed on your grad check, and know you will pass all your classes.

- For pre-completion OPT, you can file the Form I-765 up to 90 days before being enrolled for a full academic year, as long as the OPT will not begin until after you have completed a full academic year. If you have been enrolled for a full academic year, you can file the Form I-765 up to 120 days prior to the requested OPT start date.
- For post-completion OPT, you can file the Form I-765 up to 90 days before your program end date and no later than 60 days after your program end date.
- The Form I-765 must be received by USCIS within 30 days of the date your advisor made the OPT recommendation in SEVIS (see page 1 of the printed Form I-20 for the date).
- If you move and do not provide USCIS with your new address, your EAD will be returned to USCIS. To change your address, submit an online Form AR-11 to USCIS, and ask your DSO to update SEVIS.
- Your OPT employment must be directly related to your field of study and cannot begin until you have the EAD card in hand (and the start date has arrived).
- F-1 status is dependent upon full-time employment or volunteer service while on post-completion OPT.
- You cannot accrue more than 90 days of unemployment while on post-completion OPT. If you are close to 90 days, consult with your DSO.
- You will need to continue to update your DSO with address changes and changes in employment while on postcompletion OPT.
- When you receive your EAD card, email the International Office a copy of it.
- Enter your job information in your SEVIS portal, you will be emailed those directions from USCIS. You only have 90 days of unemployment (see your EAD card for the start date of your 90 days of unemployment, weekends and holidays count towards your unemployment days). If you don't enter your job details in your SEVIS portal within 90 days, your OPT i20 will be cancelled. It is your responsibility to enter your job details.
