6. Referrals

- a. Referral 2425 # 26 Class Cancellation Deadlines
 - -J. Deal opened the floor for brainstorming and discussion; everyone contributed and a consensus emerged: -The mission of the university along with the needs of students should be paramount, which includes the understanding that programs differ and often cannot be held to the same numerical course enrollment standards, especially at the graduate level. It was pointed out that this is not the same thing as saying that ailing programs not critical to the university's mission will not be subject to review.

- -A specific point raised by T. Holliwell is that financial aid is disbursed to students on the 10th day preceding the first day of class, which points to the need of a general practice of not cancelling classes after that time.
- -The U of Illinois Chicago guidelines might serve as a good general model as D. Wu and J. Deal draw up a first draft of a CSUB class cancellation policy/set of guidelines.
- -Referral 2425 # 27 Program Discontinuation Moratorium Policy
- -the committee had very little time to discuss Z. Zenko's proposed improvements to the process but was asked to consider them closely for our upcoming discussion next meeting; committee members were asked to bring specific suggested improvements/considerations to the next meeting, if they had any.

- a. The AAC would still like to hear from a representative from Spanish on their ideas for DE courses but must continue to wait to invite them until there is less on the agenda.
