



### Auxiliary for Sponsored Programs Administration (SPA)

Article II- Section 1: Mission: The mission of the CSUB SPA is to support and further the educational mission and related strategic plan of California State University, Bakersfield (University) by facilitating research, workshops, conferences, institutes, and other projects that enrich the scholarly endeavors of faculty and students and enhance the services provided by University to California communities.

Article III-Section 2-Number of Board Members: The Board shall consist of no fewer than twelve (12) and no more than fifteen (15) voting members including: six (6) members recommended by the Provost/VPAA and appointed by the University President including: four (4) faculty members, with consideration given that there be one (1) from each school, who shall be tenured or tenure-track with direct and recent experience in sponsored research or related projects, and two (2) University school dean members, appointments and reappointments by the University President shall be communicated to the Board Secretary and Board Treasurer on or before May 1.

One (1) faculty member appointed by the University Academic Senate who shall be tenured or tenure-track with direct and recent experience in sponsored research or related projects. five (5) ex officio members who shall be the University's President, Provost, and Vice President for Business and Administrative Services and Chief Financial Officer, and the Associated Students Incorporated's (ASI) President and Director of Graduate Students, or designee. five (5) ex-officio members: President, Provost/VPAA, VPBAS and CFO, ASI President and Director of Graduate Students, or designee.

Article III-Section 4: Terms: ... The faculty member appointed by the University Academic Senate shall serve for a term of two (2) years, or as long as he or she is a member of the faculty, whichever is shorter unless terminated earlier on the basis of the member's death, resignation, removal, or disqualification. The faculty member appointed by the University Academic Senate so elected shall not be eligible for immediate reelection.
