b. Provost Report (J. Rodriguez)

 - Concerns voiced from faculty regarding the use of funds and the state of the budget crisis for the university. In particular, there are concerns about the addition of refreshments for Senate meetings. Interim Provost Rodriguez clarified that funds being used are foundation funds, not stateside funds, and are approved for these hospitality purposes.

ii. Acting Dean of Arts and Humanities

- 1. A. Rodriquez has been appointed as Acting Dean of Arts and Humanities with her appointment to end March 31, 2024. Interim appointment was not made due to the timing of Dean Frakes's announcement, which was made after the last Executive Committee meeting of the fall semester. Discussion continued regarding the extension of the interim appointment of the Associate Dean. If current Interim Associate Dean appointment is extended for an additional six months, ending June 2024, it would mean he has been in this interim appointment for 24 months. Concerns voiced regarding the position being extended past that period. Will revisit after an Interim Dean has been appointed.
