It has been lowered to 3.0 and includes interviews about program expectations. These changes may help with attrition.

- Survey E. Correa had discussion with arts community about representing campus as an HSI – The Provost Office and Facilities each invested \$15,000 in campus murals. The need came out of the Campus Climate Survey. (V. Harper) There are a lot of suggestions that have to be taken. We started with what would help the students recognize something relatable to them.
- Q: How does the \$100,000 set aside for facilities help pay for more space for counseling services? (J. Millar) Decisions go through the Space Management Committee. There are requests for instructional resources and for research. V. Harper is biased toward scholarship. There is a larger deferred maintenance pool and it's difficult to get certain requests placed on that. It's up to the Space Management Committee to balance space for research and faculty office space. (V. Harper)

  - i. <u>RES 222315</u>- "Academic Probation" Terminology Change *AAC and AS&SS* E. Correa supports the resolution. Vote resulted in unanimous approval.
- G. Open Forum

Topic: Technology driving policy and procedures – Drop request after drop deadline form was emailed to M. Rees for her to sign rather than provide an opportunity to have a mentoring conversation with the student on the implications. The chance for communication with students is missing. Suggestion: Insert a button on the form that notifies the student that they must contact

faculty on this matter. (M. Rees)

Topic: Requests when advisors initiate Adobe Sign – A student wants to add two courses. One instructor says yes and the other says no. How does the chair respond? A suggestion is to have some type of guidance or policy to follow when a student initiates forms in conjunction with an advisor. (J. Tarjan) If the process were to have students meet with Advisor, the meeting may be delayed due to the advisor's workload and may not in the student's interest to wait. (K. Ziegler) This is an item to be included in the EC agenda for further discussion. (A. Hegde)

Topic: Final Exams scheduled during Commencement – If a student is affected by a conflict, refer to RES 212218 Final Exam Policy – Interim Policy Change. (M. Danforth)

Topic: Academic Integrity – There is discussion about cheating using AI platforms. We could redefine academic integrity and inform instructors how they can determine if the work the students submit is really their work. (D. Wu) Comment: 1) There are amazing tools that create content off other peoples' content 2) the AI software does not do a good job at providing sources and there are requests that more sources are added 3) Vendors are working toward offering their own Al detection tools. Thus far, Al detection software is only 8-20% accurate (F. Gorham) Suggestion: The Senate could take up Al. Perhaps form an Interdisciplinary Task force or something. (J. Tarjan) The Statewide Chairs began discussion about ChatGPT and other Al programs. (A. Hegde) Topic: Skipping waitlists - A student sits in the class and then asks to be added without respect to the waitlist. Some students get in the course before others on the waitlist. How does the system allow it to happen? (T. Salisbury) When a seat opens up in a course and the system pulls students from the waitlist, there is a check of max units, holds, time conflicts, etc. which allows students on the waitlist who have no such issues to jump ahead of those on the waitlist with such issues. Students on the waitlist with such issues have to watch for an opening then check with the department Administrative Support Coordinator to be manually added before overnight waitlist processing, otherwise someone is going to bypass them. (M. Danforth) Topic: Safety protocols discussed at DCLC (E. Correa) – Faculty members are concerned about physical safety on campus. The Police Chief Williamson to be invited to the Senate to hear faculty concerns. Please ask your colleagues to share their concerns and submit them to the Chair. (A. Hegde)

# AIMS GE Program Activity Report Spring 2023

#### Summary of course approvals

GECCo received 12 course proposal during the fall 2022 semester. All but one course were approved. The course that was not approved was withdrawn from consideration by the proposer to implement a redesign based on feedback from GECCo.

The eleven courses that were approved fall into the following categories;

- 1. BA 1028 for FYS and the SELF requirement.
- Four new GWAR courses. CHEM 3908 and 3948 satisfy major, GWAR, and SELF requirements. NURS 4218 satisfies major and GWAR. PHIL 3318 added the GWAR requirement to the continued approval as UD Area C with critical thinking and written communication reinforcement.
- 3. RS 2018 was approved for LD C2.
- 4. RS 4908 was approved for Capstone.
- 5. RS 1118 switched from oral communication to written communication reinforcement.
- 6. SCI 3019, UD Area B, changed its number to SCI 3018 course and switched from oral communication to written communication reinforcement.
- 7. SCI 3319 and 3329, UD Area B , changed to GEOL 3318 and 3328r while maintaining all other attributes.

#### Listing of substantive changes to course goals and learning outcomes

Area A2 and GWAR student learning outcomes were updated based on recommendations received from the GWAR committee. This update also included an update to the rubrics used to evaluate student work.

#### **Achieving Integration Mastering Skills**

#### **Summary of assessment activities**

During the 2021-22 academic year, American Institutions, Areas B, C, and D, and Diversity were assessed. The scoring of student artifacts was completed by June 2022 and the GE assessment coordinator, Dr. Andreas Gebauer, performed the analysis of assessment results during the summer. The assessment reports for each area assessed during 2021-22 was distributed to the department chairs of the departments providing courses in each of the areas. This was done with the request to discuss the reports with the department faculty and provide feedback to the GE program. Thus far, no responses were received. In Fall 2022, the GE Assessment Coordinator produced the GE Assessment Report 2016 -2022. This report brings together assessment results of all GE Program Learning Outcomes (but SELF) obtained since the AIMS GE Program was instituted. The report was distributed to the general faculty and to GECCo in Fall 2022 and further discussed during the GE Winter Institute 2023. The analysis of faculty feedback received during the Winter Institute is ongoing and will inform any actions taken by GECCo to further improve the GE program.

The GE assessment coordinator also updated the General Education Taskstream workspace with all results as well as any action plan implemented by GECCo.

#### Summary of grant-related activities

With the transition from Title V Grant funding to stateside support, the assigned time of the GE Director was reduced by 37.5% (from 24 to 15 WTUs). This lack of support precludes grant writing activities. Also, please note that funding agencies do not fund existing programs and ideas. Only new ideas and programs have the possibility of obtaining external funding support. A clearer definition of expectations in this regard is needed since neither GECCo nor the GE Director are authorized to change the structure or content of the AIMS GE Program. This definition should be tied to the support that is actually provided. This is even more important with the mission creep that has taken place since 2016 and the addition of further responsibilities to the GE Faculty Director position.

#### Listing of faculty development activities undertaken relative to general education

The GE program was not able to offer a GE Summer Institute at the beginning of the 2022-23 academic year because the GE budget was not finalized before September 2022. A timely approval of a GE budget is needed to offer faculty development programs.



#### **Achieving Integration Mastering Skills**

The late budget enabled the GE program to offer only four learning communities during Fall 2022. The learning communities and the number of participants were:

Oral Communication, 8 participants Critical Thinking, 5 participants Quantitative Reasoning, 3 participants Diversity, 5 participants

On January 18, 2023, the AIMS GE program held the GE Winter Institute 2023. The institute was attended by 54 faculty.

During Spring 2023 semester, five learning communities are taking place. The topics of the learning communities and the number of participants are:

Oral Communication, 4 participants Written Communication, 10 participants Critical Thinking, 7 participants Quantitative Reasoning, 9 participants Diversity, 11 participants

The overall number of learning communities is down from seven learning communities during both fall and spring semesters of previous years. This is due to reduced funding made available to the GE program.

## Summary of course review activities and results

With the transition from Title V Grant funding to stateside support, GECCo members do not receive any assigned time for their service (it was 3 WTU every second year). In light of diminishing support, it is recommended that the CSUB Academic Senate either reduces the expectations placed on GECCo service or actively supports requests for additional funding for the AIMS GE Program.

GECCo recently completed a review of syllabi present in Taskstream for the 2020-21 academic year. The review (see attached "GE Syllabus Review" report) indicates an increase if syllabi uploaded to Taskstream. This is likely due to the syllabus reminder sent to all faculty teaching GE courses at the beginning of each semester.

#### **GE Syllabus Review**

#### 2021-22

With the creation of the AUMS GE program, the CSUB Academic Senate also established guidelines for syllabus content. Specifically, the following requirements were established (among others):

- 4. the PeopleSoft description of the course, including any prerequisites;
- 5. the established Course Requirements for GE Areas;
- 6. the Student Learning Outcomes (SLOs) for the GE Area, as well as any SLOs specific to the course;
- 7. the connection of all SLOs (GE area, and course-specific) to the activities and/or assignments students will complete to demonstrate they have met the SLOs;

These requirements were only slightly modified by the General Education Curriculum Committee (GECCo) as only skill student learning outcomes are required to be linked to assignments, not all GE SLOs.

Of the 1089 sections of GE courses taught during Summer, Fall, Winter Intersession, and Spring semester of the 2020-21 academic year, 46.6% (508) sections had syllabi uploaded to Taskstream. This includes some courses (ENGL 1109, 3109 and 3119) for which master syllabi are present. Of the 508 syllabi that were found in Taskstream, 74.1% contained some type of GE learning outcomes. The previous review of GE syllabi performed by the external reviewer, Dr. R. Steven Daniels, of syllabi for the period between 2016/17 and 2018/19 academic year found 32.1% of syllabi present in Taskstream (see PSI 20-001).

Table 1 provides the analysis of syllabi found in Taskstream by GE requirement. It shows that all syllabi for First-Year Seminar (FYS) sections and Student Enrichment and Lifelong Fulfillment (SELF) sections listed the correct GE learning outcomes. The second highest percentage of proper GE learning outcomes were present for foundational skill course sections. However, only 76% of the syllabi had the skill learning outcomes inked to assignments. The next highest percentage of syllabi with 88% complete GE SLOs was found for GWAR sections, but only 6% of the syllabi listed the correct course prerequisites. For American

Institutions course section (History and Governments), 75% of GE SLOs and skill SLOs were present, but only 35% of the courses linked the skill learning outcomes to assignments. Capstone courses (69% GE SLO, 42% Skills SLO and linkage), JYDR courses (65%GE SLO, 65% Skill SLO, 17% skill linkage), thematic courses (56% GE SLOs, 38% theme, 49%,kill SLOs, 26% linkage), and large lecture format courses (38%GE SLOs) round out the GE requirement list.

Table 2 shows the number of sections offered under each course prefix and the percentage of section syllabi found in Taskstream. It further indicates the percentage of the syllabi that are present that include GE SLOs and how these GE SLOs relate to the various requirements. Please note that the percentages reflect that course syllabi are expected to contain only the GE SLOs the course is approved for.

# Report to Academic Senate for AS&SS February 9, 2023

Vice Chair, Dr. Alicia Rodriquez chaired the meeting in my absence. As she is unable to attend the Senate Meeting, I am providing feedback on her behalf. AS&SS discussed Referral #21 – Director of Advising with Dr. Harper. The committee asked clarifying questions about the proposal and memo that was created in support of this position. Some suggestions were requested. Referral #19- ATI and the IMAP Appendix was also discussed with Alex Slabey. Dr. Melanie Taylor provided a draft alignment of the existing handbook information, and the committee reviewed it with questions to Alex for clarification in meeting the intended needs of the Chancellor's Office new goals. Referral #28- Testing Center was discussed in terms of AS&SS members taking the lead on the sub-committee taskforce to provide a more thorough report with budget details and comparative information of testing centers at other CSU's that are similarly situated to CSUB. The sub-committee has not yet met to move forward with this review.
